17.1	The Chairman welcomed all to the meeting and reminded those present that the meeting	
	would be recorded.	
	The Chairman noted that future Parish Council recordings will be used for minuting	
	purposes only and will not be published.	
	3 Councillors have resigned since the last Parish Council meeting. The formal process to	
	replace them has commenced. A co-option process will be added to the agenda for the next	
	meeting.	Clerk
17.2	Apologies for Absence: Lynsey Smith and Jo Baber	
17.3	Declarations of Interest: There were none.	
17.4	Dispensations: None were requested.	
17.5	Public Forum. A member of the public asked whether information could be shared on the	
	reasons for the recent resignations. The Chairman advised that it was the choice of the 3	
	Councillors and members of the public were free to ask them for their reasons.	
	The member of the public also raised concerns about the closed sessions the Parish Council	
	have recently had. The Chairman assured all that the items for discussion necessitated	
	closed sessions but that the Clerk had minuted as much information as possible.	
	The Chairman used this opportunity to express her thanks to the 3 councillors that have	
	recently resigned. Stuart Gemmill has been a Parish Councillor for 30 years and has	
	contributed much to Stradbroke both as a Parish Councillor and as his time as a District	
	Councillor. Both Oliver Last and Don Darling have used their time on the Parish Council to	
	do good work.	
	MJ stated that all should respect their decisions to resign.	
17.6	Minutes of the meetings:	
	The minutes from the 10 th June were approved by majority vote with 1 abstention.	
17.7	Policies/Procedures:	
	Councillors voted unanimously to adopt the Grievance and Disciplinary Policy.	
17.8	Committee Structure:	
17.8.1	Councillors voted to form a new Personnel Committee, it was agreed that membership of all	
	committees would be reviewed once the 3 vacancies were filled.	
17.8.2	Counillors voted that a working party of CE/CB/EW/MJ would meet to review terms of	
	reference for all committees and these would be added to the agenda for the next meeting.	
17.9	Councillors voted that the Parish Council website would now be the official conduit of Parish	
	Council information. They noted that the Parish Council website contains links to other	
	websites within the village and noted the following statement contained on the website:	
	"All links are external to Stradbroke Parish Council and the council takes no responsibility for, nor offers any endorsement of, information on these sites."	
	The Clerk will now contact the editors of Stradbrokeonline.org.uk and ask them to remove the words "endorsed by the Parish Council" from their website.	Clerk

17.10	Clerks report:	
17.10.1	The Clerk raised concerns made to her about the closure of Parish Council meetings to the	
	public. Councillors noted that unfortunately there had been cause over recent months to	
	close meetings. Going forward a full explanation as to why it is felt the meeting should be	
	closed and a formal resolution will be passed before the public are excluded.	
17.10.2	The Clerks has received an email about a possible wasps nest in the cemetery. It was noted	
	by councillors that there is little that can be done to prevent this but it would be monitored.	
17.10.3	LO.3 Essex & Suffolk water apologised for the invoice that was issued and have noted on their	
	database that the postcode is for a cemetery. The Clerk used the opportunity to inform	
	them of the yellow marker on Bishops Way that has fallen over.	
17.10.4	The Clerk had been asked to find out the ownership of land previously used as allotments in	
	Grove End – NS confirmed that this land is owned by MSDC.
